GENERAL INSTRUCTIONS

Please provide all requested information and documentation. Failure to do so may result in a denial of your Claim. Claim Forms must be received no later than April 17, 2018. If you have questions regarding this Claim Form, please call 1-855-229-7149. Your deck may be inspected in order to determine whether you are eligible for benefits. Make a copy of all submissions, as no documents or photos will be returned.

Claim Forms and supporting documentation may be submitted in the following ways:

1. Online filing.
 - a. Go to www.AzekDeckingSettlement.com, where you can enter your information and provide uploaded documentation online; or
 - b. Print this Claim Form and complete it. Then upload it and required documentation and e-mail to info@AzekDeckingSettlement.com.
2. Mail-in filing.
 - c. Print this claim form and complete it. Then mail it and required documentation to Azek Decking Settlement, c/o Dahl Administration PO Box 3614, Minneapolis, MN 55403-0614.

II. REQUIRED DOCUMENTATION

To be entitled to recovery under the terms of the Settlement Agreement, Claimant must provide: (1) Proof of Ownership; (2) Photographs; and (3) either Proof of Purchase or the Seller Verification Form or the Alternative Documentation Forum. Failure to submit any of the required documentation will result in the denial of the Claim.

- Proof of Ownership:** Claimant must provide documents showing both:
 - (1) you are the current owner of the property where the Decking is located; and (2) you owned it at the time the Decking was installed.
 - Current Owner Documentation (common examples include dated property deed or title, property tax statement, mortgage statement, or utility bill); and
 - Ownership at Time of Purchase Documentation (common examples include dated property deed or title, property tax statement, mortgage statement, or utility bill).
- Photographs:** Claimant must provide photographs that verify the color of the Decking and the amount of Decking you purchased. If submitted by mail, photographs must be at least 3 inches by 5 inches and have the property address and Claimant's name written clearly on the back.
 - Color photographs must be sufficient to capture the entire deck. It is suggested that the photographs be taken from 4 (four) different vantage points.
 - At least 1 (one) color photograph must capture a close-up of the decking boards. Before taking the photograph, write your name, address, and the date on a piece of paper and place the paper on the part of your decking to be photographed. The paper and its contents must be visible in the close-up photograph you submit. Date-stamped photographs shall not substitute for this requirement.

Claimant must also provide documents required as Proof of Purchase, or must submit either the Seller Verification Form or the Alternative Documentation Form . Please indicate the selected option below.

- Proof of Purchase:** Claimant must provide documents that both:
 - (1) demonstrate the color, quantity, and price of Decking purchased; and (2) verify your payment and payment date.
 - Documentation demonstrating all of following: the color, quantity, and price of Decking purchased (common examples include an itemized sales receipt or invoice showing the color, quantity, and price of the Decking, or a contractor's bid showing the same); and
 - Documentation verifying purchase and date of purchase (common examples include a dated credit card statement or cancelled check demonstrating payment).
- Seller Verification Form:** If Claimant is missing any of the documentation required under Proof of Purchase, Claimant must instead complete the Seller Verification Form. Claimant must print the Seller Verification Form below, have the person who sold the Decking (e.g., contractor) complete it, and then submit the completed form. If Claimant is unable to complete the Seller Verification Form (for example, if the seller cannot be located or is unwilling to complete the form, Claimant may submit the Alternative Documentation Form. By submitting the Alternative Documentation Form, you are not ensured of settlement benefits; however, the Settlement Administrator will consider your specific circumstances to determine if an accommodation will be made. Any settlement benefits paid pursuant to the Alternative Documentation Form will be calculated using the figure of \$2.75 per lineal foot. The Alternative Documentation Form is located on the Settlement Documents page of the settlement website, www.AzekDeckingSettlement.com.
